With reference to LPG Gas Dealership, it is clarified that the prices/details given in the brochure hosted on the website and as mentioned below, will be applicable for selection of LPG Gas RO Dealership 2025 and on all the selected applicants.

In LPG Gas Seva Kendra, all applicants (all categories) can apply online by logging in to the LPG [www.lpggasdealerchayan.in](http://www.lpggasdealerchayan.in) there is no difference between LPG Dealership and normal LPG Gas except a difference in investment (Investment in LPG Gas Seva Kendra is about 20% less than normal lpg gas) and to understand the difference applicants can refer to the "Retail Outlet Investment Detail" Para 2.

#### **Guidelines for selected applicants**

- The Applicants can check the result of the draw by visiting the portal [www.lpggasdealerchayan.in](http://www.lpggasdealerchayan.in) on the date and time of the draw.
- It will be mandatory for the selected applicants to deposit an Initial Security Deposit (ISD) of Rs. 1,50,000/- within 7 days, failing of which will lead to cancellation of dealership within 7 days.
- The verification of documents will be started only after depositing the initial security deposit (ISD) and after verification of documents the process of site survey (FVC) will be completed as per the policy.
- The Applicant's (Group 1 and 2) will have to upload the property documents online on the user portal within 7 days after issuing of allotment letter.
- The Allotment letter will be sent to applicant's registered email id after 3 days of completion of draw result process, 7 days will be counted from the date mentioned on the letter.

- The Group 3 applicant will have to provide land on rent or lease for the applied location for 10 years (10 years agreement), after depositing the initial security amount, the applicant will be given 45 days to complete the process.

**1. refundable application fee detail:** Rs. 25,000/- (for all categories).

(This fee is mandatory for all applicants and is refundable in case of non-selection in draw within the period of 7-14 days\*).
